#### HIGHLIGHTS FROM EARLY LEARNING AND CHILD CARE IN ALBERTA

 National survey of early learning and child care services in April and May, 2020 (a snapshot of the week of April 27 to May 1)

 Significant impacts of the pandemic on early learning and care services (centre-based care, school age care, preschools and family child care)

 Early learning and care sectors fared differently across Canada – linked to starting conditions and government support during the pandemic

Reporting of Alberta results – Muttart Foundation and Canadian Child Care Federation

Key challenges looking ahead to reopening and recovery

### ALBERTA SURVEY RESULTS — SOME HIGHLIGHTS AND COMPARISONS

Alberta early learning and care services headed into the pandemic facing challenges and uncertainty – provincial service and funding cuts

Alberta government support for centres required to close more limited than in other provinces – only modest supports for family child cares that remained open

During the survey reference week (April 27 to May 1)

 $_{\circ}$  85% of AB centres closed – 85% of AB family child care homes open

• Centres providing emergency child care – median enrolment of 5 children

Family child care homes that remained open – enrolment fell by one third



# THE FINANCIAL SITUATION OF SERVICES EARLY IN THE PANDEMIC

The majority of services in a worse financial position than before the pandemic – more so than the rest of Canada

81% of AB child care centres in a worse financial situation –
 close to 2/3rds 'much worse' – the highest rate of any province.

 80% of AB family child care providers in a worse financial position

The areas of financial difficulty centres reported:

meeting fixed costs (AB 70%)
meeting wage/salary costs (52%)



#### THE LOSS OF GOVERNMENT FUNDING

Nationally, child care centres worse financial situation linked to the loss of parent fees

In Alberta, 7 out of 10 centres also reported the loss or reduction of government funding as a contributing factor

#### Percentage of child care centres receiving amount of normal (pre-COVID-19) government funding



## WILL SERVICES REOPEN?

A smaller proportion of closed AB centres (56%) said they will 'definitely reopen' compared to other regions of Canada – 71% in BC, 66% in ON

One in five closed AB centres are either unsure of reopening or say they will 'probably' or 'definitely' remain closed – double the proportion in BC and ON

64% of closed AB family child care homes say they will 'definitely reopen'.

One in four closed AB family child care homes are either unsure of reopening or say they will 'probably' or 'definitely' remain closed – higher than in BC and ON





#### Percentage of staff layoffs because of COVID-19



#### WHAT HAPPENED TO EARLY CHILDHOOD EDUCATORS?

AB centres reported the highest proportion of staff layoffs across the country

# WHAT CHALLENGES DO SERVICES ANTICIPATE AROUND REOPENING?

The vast majority of Alberta child care centres anticipated problems around **reopening and the resumption of service** delivery – a similar theme nationally

9 out of 10 AB child care centres anticipate challenges with lower enrolments and health and safety costs
7 out of 10 AB child care centres anticipate challenges with the cost of reopening

The majority of family child care homes see similar challenges

7 out of 10 AB family child care providers anticipate challenges with lower enrolments
5 out of 10 AB family child care providers anticipate challenges with health and safety costs





## LOOKING AHEAD

The impacts of the pandemic on early learning and care services in AB means that reopening and recovery requires significant **new public investments** 

Government of Alberta relief package announced in May – (\$17.8 million over three phases – phase 3 investments pending) probably insufficient given sector needs

Anticipated challenges

- Lower enrolments (due to new service guidelines and changed family economic situations)
- Additional health and safety considerations (hard costs and allocation of staff resources)
- The return and retention of early childhood educators

Potential Provincial and Federal investments to support reopening and recovery

• Unallocated provincial monies for child care (amount to be determined)

- One-year bi-lateral agreement monies (est. \$45.6 million)
- Federal 'Safe restart' monies (est. \$60 to \$65 million for ELCC)
